

# **CAR WASH SHOW AUSTRALIA 2022**

## **Terms and Conditions**

- Exhibitors and Sponsors must be current financial Australian Car Wash Association supplier members, and only registered Exhibitors can be Sponsors.
- Exhibitor Identification To ensure access, Exhibitors must collect their Show Lanyards on Tuesday, 20 September from the Show Registration area outside the Exhibit Hall at ICC, Darling Harbour, Sydney.
- Exhibitors must wear their Show Lanyards at all times over the two days of the Show and at the Show's Social Events.
- Exhibitors must not assign, sublet or apportion space without prior written consent from the Car Wash Show Australia 2022 Team.
- Exhibitors should not exhibit, advertise, or offer for sale products or services other than those manufactured or sold by it in the regular course of business.
- No Exhibitor may display products or services for his company outside the confines of his assigned booth space in Exhibit Hall.
- Exhibitors should organise no competing activities or events from 20 September 22 September, which may distract attendees from Car Wash Show Australia 2022.
- Canvassing or attempting to make sales and/or distributing materials at the Show by anyone representing or connected with a non-Exhibitor is strictly forbidden. Any person doing so may be ejected from the Show.
- Photography, sound recording or videoing other than by official Australian Car Wash Association photographers or an Exhibitor taking photographs of their own Booth, is prohibited; any person doing so will be asked to delete the footage and hand over the equipment involved.

### **Exhibitor Guidelines**

The Australian Car Wash Association will make further Exhibitor information available to Exhibitors at Car Wash Show Australia 2022 on or about 1 April 2022. The information provided will ensure your company experiences the highest possible standard of exhibition and service.

The information will include details outlining exhibiting at the (ICC) International Convention Centre (as the Venue), including regulations/guidelines and evacuation procedures, as well as material relating to your exhibition booth and display space, bump-in, bump-out and logistics information.
