

## **CAR WASH SHOW AUSTRALIA 2024**

## **Terms and Conditions**

#### **Exhibitor Eligibility:**

- 1. Exhibitors and Sponsors must be current financial members of the Australian Car Wash Association.
- 2. Only registered Exhibitors are eligible to become Sponsors of Car Wash Show Australia 2024.

#### **Exhibitor Identification, Hall Entry and Lanyards**

- 3. To gain access to the Exhibit Hall during the official Show Days, all Exhibitors must collect their Show Lanyards from the Show registration area located outside Exhibit Hall 7, International Convention Centre (ICC), Darling Harbour, Sydney. Show Registration hours will be announced closer to the event.
- 4. Exhibitors must wear their Show lanyards at all times during the Show and associated Show Social Events.
- 5. All official name tags and lanyards will be produced using the name of the registered Exhibitor.

#### **Booth and Product Regulations**

- 6. Exhibitors must not assign, sublet, or apportion booth space without obtaining prior written consent from the Car Wash Show Australia 2024 Show Organizers (the Australian Car Wash Association).
- 7. No exhibitor may showcase products or services outside their assigned and purchased booth space within the Exhibit Hall.
- 8. Exhibitors may only exhibit, advertise, or offer products or services manufactured or sold by the Exhibitor within the regular course of their business.

#### **Uniforms and Branding:**

- 9. It is strictly forbidden for exhibitors to represent or display products or services from non-ACWA member companies on exhibition stands.
- 10. Exhibitors must ensure that all clothing, name tags, and branding used by their employees during the event exclusively reflect the brand and name of their own company and/or other ACWA members.

#### Solicitation

11. Soliciting, making sales attempts, or distributing materials at Car Wash Show Australia 2024 by individuals representing or connected with non-exhibitors is strictly prohibited. Any person engaging in such activities will be promptly removed from the Show.

#### **Activities and Competing Events:**

- 12. Exhibitors are kindly requested not to undertake any activity or event that may compete with or distract attendees from Car Wash Show Australia 2024.
- 13. Exhibitors intending to conduct external events between Tuesday 13 August, 2024 and Thursday 15 August, 2024 should advise the Australian Car Wash Association of their intentions.

### **Photography and Recording:**

- 14. Unauthorized photography, sound recording, or video recording during the event is prohibited. Exceptions include official Australian Car Wash Association event photographers and Exhibitors taking photographs of their own booths.
- 15. Those found in violation must delete the footage and surrender the related equipment.

## **Exhibitor Guidelines**

The Australian Car Wash Association will provide further Exhibitor information for Exhibitors at Car Wash Show Australia 2024. This will include details and links relating to bump-in and bump-out, as well as all terms and conditions for being onsite at the venue being the International Convention Centre (ICC) Darling Harbour, Sydney to set up Exhibitor displays. The information provided will ensure your company experiences the highest possible standard of exhibition and service.

In particular this information will outline all details for being on-site in the delivery dock and the exhibit hall as part of exhibiting in Hall 7 including access and induction requirements, regulations/guidelines and evacuation procedures, as well as material relating to your exhibition booth and display space, bump-in, bump-out and logistics information. You will also receive contact details for the contracted Show Booth builders and Logistics Company.
